#### 1. Election of Chair

Proposed by Cllr Fisher seconded by Cllr Turnill that Cllr Salt be re-elected Chair for the forthcoming year - all in favour.

Proposed by Cllr Salt seconded by Cllr Miller that Cllr Fisher be re-elected Vice-Chair for the forthcoming year – all in favour.

#### 4. Declaration of Interests

## 5. Co-Option

Proposed by Cllr Luke seconded by Cllr Salt that Matt Benson be co-opted onto Culford Parish Council — all in favour. The Declaration of Acceptance of Office was duly signed.

#### 6. Minutes

Proposed and seconded that the minutes of the meeting held on 27<sup>th</sup> March 2025 are approved and signed by the Chair as a true record – all in favour.

## 7. County & District Councillor Reports

Cllr Susan Glossop's and Cllr Hopfensperger Annual Reports were previously circulated and noted. Local matters included the upgrade of the battery operated Vehicle Activated Signs at both Culford and West Stow to solar power, make and model to be sent to Cllr Glossop for possible funding towards the cost; a complaint has been received of blocked drains at Icklingham Road, West Stow, the cyclic cleansing schedule shows the drains have not been cleared for two years, Cllr Hopfensperger has asked for the drains to be cleared and jetted through; although not illegal for lorries to drive through the village inconsiderate driving can be reported on the Highways Reporting Tool, publicity to inform residents about the tool to be made via the website/Facebook Page; there are a number of Grade II listed walls in Culford and West Stow requiring attention, in the first instance, Cllr Luke to make an informal approach to the owners of the walls in question and report back at the next meeting.

Following a question from Cllr Miller in relation to the Parish Council exploring funding various traffic calming measures, Including a crossing, RH to send information/link to the clerk.

#### 8. Public Forum

Two matters were raised from a member of the public:

- a) Plastic barriers across the black gates meaning that people could not access the church to visit loved ones graves by car over the Easter break. In relation to the barriers and access, this has been discussed with the PCC and the reasoning behind their decision is to keep the church safe during the holidays. Information on access can be found on the PCC St Mary's Church website. If feedback shows the school are not honouring what has been agreed, this can followed up with the relevant individuals.
- b) With regard to the automatic barrier, the school's only obligation is to ensure the width of the barrier does not exceed 1.5 metres wide when down. To be monitored.

Cllr Benson suggested that the early morning increase in the volume of traffic through West Stow, appears to coincide with the USAF base change over.
